The Association of Directors of Nursing and Midwifery (IADNAM) in partnership with the Office of the Nursing and Midwifery Services Director (ONMSD), HSE, the Office of the Chief Nursing Officer (CNO), Department of Health and the President of the Nursing and Midwifery Board of Ireland (NMBI) will be hosting an online virtual event this year to celebrate 2020 the Year of the Nurse and the Midwife.

All nurses and midwives from staff nurse and staff midwife to and including Advanced Nurse Practitioner and Advanced Midwife Practitioner grades from all divisions of the register employed in frontline services, are invited to submit an abstract for oral presentation at the online virtual event. The presentation must demonstrate examples of good practice or evidenced based practice initiatives, outcomes, or service innovations that have been or are currently being implemented. Exemplars representing each division of the NMBI register will be selected including two exemplars that demonstrate the use of technology to advance nursing and midwifery practice.

Each presentation will be no more than 6 minutes in duration and must reflect the theme of:
Reflect, Recover, Renew

Presentation to include a maximum of 4 slides indicating the following:

- Background
- Intervention
- Outcome
- Key messages/recommendations

The abstract (*250 words maximum*) should be typed in the template provided. All information requested must be included as otherwise the application cannot be considered.
