Accreditation

RCNME programmes of education are quality assured in accordance with the Nursing & Midwifery Board of Ireland (NMBI) guidance and the Quality and Qualifications Ireland (QQI) accreditation processes.





Continuing Professional Development programmes are accredited in accordance with NMBI guidance prior to programme delivery. This process ensures that the programme aim, learning outcomes, content, methods of delivery and evaluation meet NMBI CPD standards. Continuing Education Units for CPD programmes of education are awarded for each programme delivered by the RCNME, HSE Dublin and South East.

On 21 December 2011, the Nurses and Midwives Act 2011 was signed into law. This Act updated the provisions relating to the regulation of nurses and midwives in Ireland, and recognised midwifery as a separate and distinct profession to that of nursing. The Act enhanced the protection of the public in its dealings with the professions, while ensuring the integrity of the practice of nursing and midwifery (www.NMBI.ie). Enactment of the Nurses Act 2011 and current work by the NMBI Education Team will mean that, in time, evidence of CEUs are required by NMBI when re-registering with the Board.

QQI Level 5-8 programmes can only be delivered once validated by QQI as meeting the Quality Assurance processes required to achieve National Framework of Qualifications (NFQ) Level 5-8. The Consortium of Centres of Nurse and Midwifery Education (CCNME) has developed and implemented policies, procedures and processes that align with and are approved by QQI Quality Assurance measures and is therefore an approved provider of robust, evidence-based, QQI approved programmes of education and training.

The RCNME HSE Dublin and South East is an active member of the CCNME, contributing to the development, approval and implementation teams nationally for Level 5-8 programmes for Nurses, Midwives and Health Care Assistants.

Aim

The Webinar will be framed in a 'Human Rights Based" context linking in current best practice and referencing the national guidance provided by the Safeguarding Office Ireland, Health Information Quality Authority, The National Disability Services Quality Improvement Office and the provisions of the Health Act (2007).

Aim

The aim of this programme is to provide Registered Nurses with the knowledge and skills required to provide appropriate care for those who require or already have, a urinary catheter (both male & female) and those requiring a suprapubic re-catheterisation.

Who Should Attend

The assessor must be a Nurse or Senior Doctor who has completed education in the specific area and deemed competent in adult male catheterisation and adult suprapubic-re-catheterisation. The assessor must be identified prior to programme commencement date.
- Participants must have read the HSE local policy/guidelines, Guidelines for Insertion, Removal, Care and Maintenance of Urethral Catheters in Adult Male & Female Patients.

Designated ECT Nurse Education & Training Programme

Aim

The aim of this programme is to equip the Designated ECT Nurse with evidence-based theory, clinical standards and guidelines to enhance their theoretical knowledge, technical skills, confidence and competence to perform pre-ECT treatment assessments, monitor the ECT procedure, observe and interpret post ECT treatment responses in the management of the adult requiring prescribed ECT.

Learning Outcomes

At the end of this programme, participants should be able to:

- safely and competently undertake a holistic nursing assessment of the individual patient undergoing ECT and develop an appropriate plan of care for the perianaesthesia period;
- explain the pre-ECT assessments (capacity to consent, consent, pre-anaesthetic assessment, anaesthetic risk, mental health state) must be completed and filed in the patient's clinical file. Prepare the service user for the ECT procedure;

Supporting a Person with an Intellectual Disability through **Grief & Loss**

We are responsible for the education needs of all nurses and midwives, across all disciplines, in Carlow, Kilkenny, South Tipperary, Waterford and Wexford.


